## **Holland History**

Holland Medical High School is a unique, collaborative partnership with Hardin-Simmons University, a private, higher-education institution, and the Abilene Independent School District. Built on the northeast corner of the beautiful HSU campus in north Abilene, Holland Medical High School is located near the largest medical community in West Texas, Hendrick Medical Center.

Holland opened its doors in 2007 in the pursuit of a mission to prepare quality healthcare workers to meet the needs of the Abilene community. Currently an average of 150 students from Cooper, Abilene High and ATEMS High School attend classes at Holland. Enrollment at Holland MHS requires 9<sup>th</sup> and 10<sup>th</sup> grade pre-requisite courses in the Health Science graduation program and a student application in the spring before participation during a student's junior or senior year. Students in CNA, RDA, CCMA and Pharmacy all test for the appropriate certificates following completion of course requirements. Students completing the DHS course receive Basic Life Support and "Stop the Bleed" Certificates.

<u>Office Hours:</u> Holland Medical High School office is open 7:45-3:45 each day. Additional hours can be arranged by appointment, by calling 794-4120. The office follows the school district calendar posted on the Abilene ISD website.

<u>School Day Hours:</u> Students may attend programs at Holland Medical for two, three or four consecutive classes. The morning bell rings at 8:05. Students are dismissed at the end of the day at 3:45 pm. Students must be enrolled in AISD at Abilene High, ATEMS or Cooper to be eligible for the programs at Holland Medical. (See all high school Bell Schedules posted on the AISD webpage for details on exact course times.)

#### **Guidelines for Success**

Student Behavior Management: Holland students are expected to abide by the AISD student code of conduct as set by AISD provided on the AISD website and their home campus administration. Additionally, Holland students must also follow all codes of conduct and behavior as set forth by the clinical sites affiliated with Holland Medical High School. Failure to follow the codes of conduct may result in the removal of a student from the programs offered at Holland Medical High. As required by law, the designated campus behavior coordinator for Holland Medical High School is Kathryn Walker, Dean of Students. **Bullying**: Bullying may occur when a student or group of students engages in written or verbal expression, expression through electronic means, or physical conduct that occurs on school property, at a school-sponsored or school-related activity, or in a vehicle operated by the district and a school district's board of trustees or the board's designee determines that the behavior:

- 1. Has the effect or will have the effect of physically harming a student, damaging a student's property, or placing a student in reasonable fear of harm to the student's person or of damage to the student's property; or
- 2. Is sufficiently severe, persistent, and pervasive enough that the action or threat creates an intimidating, threatening, or abusive educational environment for a student.

This conduct is considered bullying if it:

1. Exploits an imbalance of power between the student perpetrator who is engaging in

bullying and the student victim through written or verbal expression or physical conduct; and

2. Interferes with a student's education or substantially disrupts the operation of a school.

A student or parent who has a complaint alleging bullying should immediately report the complaint to a campus administrator, teacher, or counselor. During this initial complaint, a bullying report form will be completed. You may access one of these forms online through the home campus or AISD webpage. Bullying complaints at Holland will be investigated through the student's home campus administration in partnership with Holland staff.

**School Resource Officer:** Holland Medical High School is located on the Hardin-Simmons University campus. Campus security is maintained by the Hardin-Simmons Police in conjunction with AISD Resource Officers. AISD Resource Officers may be contacted as needed by Holland Medical for those situations pertaining to AISD students or parents. Traffic incidents are subject to university policy.

#### **Daily Procedures**

<u>Early Arrival</u>: Students are welcome to arrive to campus early for the purposes of tutoring or making up assignments. Students should arrange a time with their instructor(s) or the Dean of students regarding early arrival to campus.

<u>Arrival:</u> The Holland building is open for students at 7:45 am Monday -Friday. Holland Medical High School occupies the bottom floor of the HSU Holland building. Students are permitted to enter their classrooms or may wait in the foyer upon arrival. Students are not permitted upstairs or in the elevator.

**School Dismissal:** Students may be leaving the Holland campus after second, third, fourth, sixth or eighth periods. After each students' last class, students are expected to leave campus immediately. Shuttle buses to home campuses will be located in the front of the Holland building on Cedar street and should be boarded as soon as they arrive. Further information regarding buses and transportation may be acquired by contacting Abilene ISD transportation at 677-1444. Additionally, shuttle information will be available for students that need transportation to and from the Holland campus from their home campuses.

<u>Traffic and Parking:</u> Students must park in the parking lot behind Holland Medical High School on Vogel Street. Students do not need an HSU parking permit but must have a CHS/AHS/ATEMS student parking sticker displayed. If students are parked in a lot, street or space not designated for Holland students, they can be ticketed by HSU Police. Please practice safe and courteous driving as Holland is located on a college campus with heavy student foot traffic and vehicles traveling throughout the day. Students must refrain from parking in spaces marked for faculty and staff or visitor and handicap parking clearly marked in front of the Holland building on Cedar street. If you need additional information about parking please call 794-4120.

<u>Visitors & Guests:</u> To ensure the safety of all at Holland, we require that all parents and visitors report to the Holland Medical High School office and present a valid driver's license to enter a classroom or go beyond the office. A visitor's pass will be issued through the campus security system and must be returned when a visitor is leaving.

Visits to individual classrooms during instructional time are permitted only with approval of the Dean of Students and teacher, and if their duration or frequency does not interfere with the delivery of instruction or disrupt the normal school environment.

**IDs:** All students attending Holland Medical High School will be issued an ID that designates them as a Holland student in our medical program. The Holland ID is in addition to the student's home campus ID (Abilene High, ATEMS or Cooper High). Students are required to wear both IDs while attending clinicals or representing Holland Medical High School in any school sponsored function or activity. The cost of replacement for a lost or destroyed ID is \$5.00. A new ID may be purchased through the Holland officebefore school, during break or after school.

## **Absences and Tardies**

**Reporting Absences:** The Holland curriculum requires classroom instruction, and clinical rotations. It is expected that students make every effort to be in class and at clinicals. However, If a student needs to miss class, the parent or guardian must call the Holland office to report the absence to the campus secretary. Students will be expected to make up missed class and clinical time to meet program requirements.

Students missing more than five class days shall be addressed by the Dean of Students and could be referred to the home campus administration. Severe absenteeism may result in removal from the Holland program.

<u>Tardies:</u> Promptness is vital for Holland Medical High School classes. Being late to clinicals causes the student to miss critical hours required for certification programs. Teachers will close classroom doors at the start of the instructional period. Any student arriving late will report to the office fora tardy pass. Students arriving more than 5 minutes late to clinicals will be marked tardy by their instructor. This deducts time from the minutes required for clinical participation and will have to be made-up. Excessive tardies affect student learning, academic performance and clinical participation. Chronic tardies shall be addressed by the Dean of Students and may be referred to the home campus administration.

Release and Return of Students During the School Day: If your student needs to be released during the school day, please call or sign him/her out at the office. The teacher will be notified and the student will be sent to the office. As a safeguard for our students, teachers have been instructed not to release students to adults unless notified by the office. Students will only be released to individuals in the AISD contact information. It is the parents/guardian's responsibility to ensure accurate and updated contact information.

If a student has a doctor's appointment during the instructional day, please request a doctor's note reflecting the visit and make sure the student returns to school as soon as the appointment is completed with the doctor's office note for appropriate absence coding. If the student is returning to campus after an appointment, documentation of appointments should be submitted to the Holland office and we will be share with the student's home campus.

#### **School Communication**

Each Holland Medical High School teacher and the Holland office has a remind account. Students will be given information from their program teacher regarding how to sign up for the Remind. Additionally, information will be shared through the social media channels listed above and via email as applicable.

#### **Lunch Procedures**

Lunch is "take away" for students at Holland Medical High School. All students will be provided with lunchservices on their home campuses (Abilene High School, ATEMS or Cooper High School) or they may reserve a "take away" lunch at Holland at the end of 4<sup>th</sup> period. Food IS NOT permitted in the classrooms at Holland Medical High School. Foods of Minimal Nutritional Value (FMNV) are NOT ALLOWED to be provided to students at any time anywhere on school premises by anyone (including guest speakers) until after the end of the last scheduled class. (FMNVs include but are not limited to any carbonated beverage, chewing gum and candy.

#### **School Nurse**

Holland Medical HS staff is comprised of teachers who are also certified nurses. However, these teachers are not school nurses. The office staff will notify parents or guardians in case of illness or emergency. Student medication is not distributed or maintained on the Holland campus unless directed by the student's home campus school nurse.

#### **Learning Resources**

**LRC:** Students have access to learning resources on the home campuses.

**Student Email Account:** Each AISD student is assigned an email account through their home campus (Abilene High, ATEMS or Cooper). A student's AISD gmail should be used to contact teachers and in any Google classroom. Students should not share email account passwords with anyone.

**TEAMS:** Students and parents are encouraged to create and access the self-serve account in Frontline for grades and attendance. Visit the AISD webpage for account creation information and access under TEAMS Grades Self-Serve.

**Xello:** Xello is an online program that helps both middle and high school students plan for future success. Xello allows students to take in-depth career, personality, and learning-style assessments, explore a comprehensive database of careers, schools, and programs, participate in interactive lessons, and utilize high school course planning tools to make course selections and develop a four-year program.

#### **Parent Information**

<u>Contacting the Teacher:</u> Each Holland teacher has an email address that can be located on the Holland website. Additionally, teachers will give information regarding their Remind accounts. Parents are encouraged to email teachers with questions or concerns. Teachers will respond to emails during planning times or after school. Teachers will not respond during an instructional period to remind messages or emails.

<u>Conferences:</u> Parents of students receiving a failing grade on a progress report or on a report card are encouraged to schedule a conference with the teacher as soon as possible. Parents and teachers may request conferences at any time. Parents are encouraged to call or email teachers when they have questions. Teachers will return calls during their planning time or after school.

HOSA/Volunteering: Students are encouraged to join HOSA. HOSA is a national student organization recognized by the U.S. Department of Education and Health Science Education (HSE) Division of ACTE. HOSA's two-fold mission is to promote career opportunities in the health care industry and to enhance the delivery of quality health care to all people. HOSA's goal is to encourage all health science instructors and students to join and be actively involved in the HSE-HOSA partnership.

Membership is open to any currently enrolled student at Holland Medical High School without regard to age, sex, race, color, religious belief, national origin or handicap. All dues paying members are part of Holland HOSA, and then divided into Chapters for the purpose of competitive events. HOSA members are encouraged to compete at local, regional, and state events as appliable and to volunteer for the numerous opportunities for HOSA and Holland students each semester.

Parents are welcome as sponsors for HOSA and Holland events, including competition and volunteering opportunities. Parents wishing to volunteer should submit their name and contact information to Jennifer Seekins, Dean of Students for Holland Medical High School.

## Policy and Procedure Required for Holland Enrollment

<u>Application Process:</u> Students attending Holland Medical High School are Abilene High School, Academy of Technology, Engineering Math or Science (ATEMS) or Cooper High School students in AISD. Students are admitted to Holland Medical High School based on prerequisite courses at Abilene High or Cooper and by application. Applications are available in early spring at both HS campuses or the Holland website. Admission determinizations are made each spring by the program committee. Admission to the program is based on grade placement, aptitude, interest, and the availability of class space.

#### **Clinical Requirements**

All students enrolled in Holland Medical High School are required to attend and comply with the ethics and standards of our clinical affiliations. For a student to be eligible for clinical rotations, they must have negative drug screens, cleared background checks, have up-to-date immunizations, and attend student orientation with copies of appropriate forms on file with both Holland Medical HS and the clinical affiliate.

**Drug Screen:** Students are required to complete a 7-panel drug screen. Drug screening is random and within the school day at HMHS. Any student absent during drug screening will be responsible for testing *that day* at Hendrick Regional Lab or as scheduled by Holland. Positive drug screens require review by a state-approved laboratory (MRO). Any student with a positive screen is subject to immediate removal from the program.

**Background Checks:** Students must have a background check conducted by Group1 and background check with AISD. Both checks are required for students to attend clinical rotations. Failure to submit background checks is grounds for immediate removal from the Holland program.

**Immunizations:** All student immunizations comply at a minimum with Texas Administrative Code 97.64. All immunizations must be kept on file with HMHS. These include:

- 2 MMR vaccines or report or positive titer
- 2 Varicella vaccines or report of history of chickenpox signed by a physician.

History of at least 1 negative TB skin test, TB Gold or T-spot blood test, or check X-ray performed specifically to rule out TB in addition to annual TB symptom screening questionnaire answering no to all questions.

Tetanus/Diphtheria booster in the past 10 years

Heb B (3 immunization series)

Meningitis Vaccine (MCV4) current with the last 5 years.

Annual Flu Vaccine (October- March) Flu exemptions must be submitted to and approved by affiliations services PRIOR to the start of clinical rotations.

COVID Vaccine as required by the medical affiliation where students attend clinical rotations.

All student documentation will be filed with Holland MHS.

<u>Program fees and Certification Exams:</u> Holland Medical High School students are administered certification exams in their chosen program(s). The district pays a portion of these exam fees, and it is expected that all students will participate in their certification exam. Additionally, each program does have cost and expectations associated with the program. Exam and program fees are as follows and payment schedules vary. Highlighted costs are optional.
