6. Indication of how the contract will be awarded:

7. Method and criteria for the evaluation of offers:

- *AIISD will conduct a comprehensive, fair and impartial evaluation of all Proposals and will analyze each Proposal to determine overall responsiveness and completeness as defined in Scope of Work and Specifications and Pricing sections. The District, in its sole discretion, may deem a Proposal non-responsive if Proposer fails to comply with the instructions in this RFP or submits an incomplete Proposal. AIISD may, in its sole discretion, eliminate non-responsive proposals from further evaluation.*
